As of ____/____/____ in consideration of the mutual promises contained herein and the payment schedule hereto attached. Servi-Tech, Inc. and _____ and _____ (if applicable), hereinafter referred to as 'Customer', contract and agree:

SERVI-TECH Expanded Premium Services, LLC shall provide the equipment listed in this Agreement:

- (Quantity) The Profiler - Economy 3 - Telemetry, solar panel, 3 sensors, stainless steel bracket, nuts, bolts. (Free S&H)
- (Quantity) The Profiler - Standard 4RB/6" or 48" - Telemetry, solar panel, 4 sensors, tipping rain bucket, stainless steel bracket, nuts, bolts. (Free S&H) 6" sensor 48" sensor
- (Quantity) The ProfilerC - Telemetry, solar panel, five-sensor 32-inch capacitance probe, stainless steel bracket, nuts, bolts. (Free S&H)
- (Quantity) The ProfilerC Rain Bucket - Telemetry, solar panel, five-sensor 32-inch capacitance probe, tipping rain bucket, stainless steel bracket, nuts, bolts. (Free S&H)

SERVI-TECH Expanded Premium Services, LLC shall provide the following services:

- (Quantity) Soil texture analysis (No Service)
- (Quantity) Install, maintain, extract and soil texture analysis
- (Quantity) Install, maintain, extract, soil texture analysis and water management

SERVI-TECH Expanded Premium Services, LLC shall provide the following imaging services:

- (Quantity) Number of fields requesting 12 images per field during the 2017 crop season.

CUSTOMER AGREES:

1. To pay equipment costs and service fees within 30 days of invoice date.
2. To pay interest at the rate of 1.33% per month (15.96% per year) on all past due accounts. Interest shall begin accruing the date the payment is due.
3. Under the terms of the purchase agreement, Customer is responsible for any damage and maintenance expenses not covered by product warranty. Warranty covers equipment defects within one year of the purchase date.
4. That Servi-Tech, Inc's liability for loss or damage sustained by the Customer as a result of Servi-Tech, Inc's negligence, errors, or omissions is limited, and the amount due the Customer for any such negligence, errors, or omissions shall not exceed the total amount paid to Servi-Tech, Inc. by the Customer for the equipment purchased and paid for under this Agreement and the Customer hereby releases and agrees to hold Servi-Tech, Inc. harmless from any and all liabilities over and above the amount limited hereby.
5. That by executing this Agreement below, he or she has the necessary corporate authority to execute this Agreement and that by signing below he or she understands that his or her individual signature shall constitute authorized signature of both the individual Customer and that of the corporate Customer (If applicable).
6. To pay all costs, expenses and accumulated interest, including court costs and reasonable attorneys' fees incurred by Servi-Tech, Inc., should Servi-Tech, Inc. be forced to file a lawsuit against the Customer to collect the amounts due hereunder or to enforce the terms of this Agreement. VENUE FOR ANY ACTION FILED AS A RESULT OF THIS AGREEMENT SHALL BE IN SALINE COUNTY, KANSAS.
